### Gamble**Aware** reveals new strategy and publishes its Annual Report

**Gamble**Aware** reveals new strategy, aiming to treble the number of people treated each year who suffer from gambling-related harm.**

Gamble**Aware** has published its new five-year strategy; reinforcing its commitment to help those suffering from gambling-related harm by funding research, education and treatment services.

The strategy reviews the charity's objective to minimise the levels of gambling-related harm in Great Britain and to support and treat those who suffer from it. Gamble**Aware** is seeking to increase its funding to a minimum of £10m a year as it calls for all those who profit from gambling, not just the gambling industry, but also advertisers, lotteries and professional sports

clubs, to contribute to research, education and treatment services. Following the appointment of a new chair of trustees, Kate Lampard CBE, the strategy demonstrates how the charity will act as an independent voice in a controversial field and fund help and support to those who need it.

Primarily we will be concerned to investigate the effectiveness of various treatment, prevention and education strategies in minimising gambling-related harm.**

## GambleAware commissioning efficient and effective treatment and brief interventions

**GambleAware is committed to commissioning an efficient and integrated system where limited finances can be directed to ensure the maximum number of problem gamblers receive the correct level of intensity of treatment for their problems to promote best outcomes and system efficiency. We will endeavour to ensure that those requiring lower levels of interventions get services suited to their needs and are not taking capacity of services designed to treat those with more severe and complex problems.**

**Also, we will seek to broaden the range of services and activities we support and work with in the future including general public awareness-raising, education and early prevention work, particularly among young people and vulnerable communities, relapse prevention, as well as exploring how we might support the development of online self-help and mutual-aid initiatives.**

All treatment services funded as part of GambleAware's developing National Problem Gambling Service implement GambleAware's pioneering Data Reporting Framework (DRF).

This ensures that data is compiled on the nature and outcomes of the treatment they provide to a nationally agreed standard. This data will allow GambleAware to rigorously evaluate these outcomes on the basis of robust and comparable evidence and inform the development of best practice and outstanding care in Great Britain.
